### **GRANT OF SHARE OPTIONS**

This announcement is made by Golden Faith Group Holdings Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rules 17.06A, 17.06B and 17.06C of the Rules Governing the Listing of Securities (the “**Listing Rules**”) on The Stock Exchange of Hong Kong Limited (the “**Stock Exchange**”).

The board (the “**Board**”) of directors (the “**Director(s)**”) of the Company announces that on 5 April 2024 (the “**Date of Grant**”), the Company offered to grant 13,200,000 share options (the “**Share Option(s)**”) to 1 director and 1 eligible employee participant (“**Grantees**”), to subscribe for an aggregate of 13,200,000 shares of HK\$0.01 each in the share capital of the Company (the “**Share(s)**”) under the share option scheme conditionally approved and adopted by written resolutions of the Company’s then shareholders on 22 July 2017 (the “**Share Option Scheme**”), subject to the acceptance of the Grantees and the payment of HK\$1.00 by the Grantees upon acceptance of the Share Options (the “**Grant**”). The Share Options represent, upon full exercise, approximately 1.98% of the total number of issued Shares as at the date of this announcement.

Details of the Grant are as follows:

<b>Date of Grant:</b>	5 April 2024
<b>Number of Share Options granted:</b>	13,200,000 Share Options. Each Share Option shall entitle the holder thereof to subscribe for one Share.
<b>Exercise price of the Share Options:</b>	HK\$0.282 per Share, representing the highest of: <ul style="list-style-type: none"><li>(i) the closing price of HK\$0.280 per Share as stated in the daily quotation sheets issued by the Stock Exchange on the Date of Grant;</li><li>(ii) the average closing price of HK\$0.282 per Share as stated in the daily quotation sheets issued by the Stock Exchange for the five business days immediately preceding the Date of Grant; and</li><li>(iii) HK\$0.01, being the nominal value of a Share</li></ul>

Save as disclosed above, to the best of the Directors' knowledge, information and belief, having made all reasonable enquiry, none of the Grantees is (i) a Director, chief executive or substantial shareholder of the Company, or their respective associates (as defined in the Listing Rules); (ii) a participant with options and awards granted and to be granted exceeding the 1% individual limit under Rule 17.03D of the Listing Rules; or (iii) a related entity participant or service provider (as defined in Listing Rules) with options and awards granted and to be granted in any 12-month period exceeding 0.1% of the total issued Shares.

Subsequent to the grant of the Share Options, the number of Shares available for future grant pursuant to the Share Option Scheme is 48,582,100 Shares.
